Fruit Marketing Organisation Amendment

- ‘Vesting of assets and liabilities of pineapple group committee** 1
- ‘**23.(1)** On the commencement, the assets, rights and liabilities of the 2
pineapple group committee vest in the other fruits committee. 3
- ‘**(2)** A legal proceeding by or against the pineapple group committee that 4
has not been finished before the commencement may be continued and 5
finished by or against the other fruits committee. 6
- ‘**(3)** This section expires on the day it commences.’. 7
