<b>Short title</b>	2
1. This Act may be cited as the <i>Anti-Discrimination Amendment Act 2000</i> .	3 4

2. This Act amends the <i>Anti-Discrimination Act 1991</i> .	6

‘(3) For this section, a ship is a ship connected with Queensland if—	17

(ii) an appeal relating to a prosecution for an offence under section 191(2) relating to the order; and	9 10
(c) the court considers that the preservation of the anonymity of the relevant person is necessary to protect the work security, privacy or any human right of the relevant person.	11 12 13
<b>‘(2)</b> The court may make an order prohibiting the disclosure of the relevant person’s identity.	14 15

(a) under section 192(1), <sup>3</sup> the tribunal makes an order that oral or documentary evidence (the <b>“relevant evidence”</b> ) must not be published, except as directed by the tribunal; and	20 21 22
(b) a court is hearing—	23
(i) a prosecution for an offence under section 192(2) relating to the order; or	24 25
(ii) an appeal relating to a prosecution for an offence under section 192(2) relating to the order; and	26 27

(c) the court considers that, in the circumstances, a court order that the relevant evidence must not be published, except as directed by the court, should be made.

‘(2) The court may make an order that the relevant evidence must not be published, except as directed by the court.

‘(3) A contravention of an order made under subsection (2) is a contempt of the court.’
