<b>2 Appropriation for 2002–2003</b>	4
(1) The Treasurer is authorised to pay \$54 673 000 from the consolidated fund for the Legislative Assembly and parliamentary service for the financial year starting 1 July 2002.	5 6 7
(2) The amount mentioned in subsection (1)—	8
(a) is appropriated for the financial year for the Legislative Assembly and parliamentary service for application to its departmental outputs, equity adjustment and administered items as stated in the schedule; and	9 10 11 12
(b) includes amounts for departmental outputs, equity adjustment and administered items delivered by the Legislative Assembly and parliamentary service in the financial year starting 1 July 2001 but for which it has not been paid in that financial year.	13 14 15 16
(3) The amount mentioned in subsection (1) includes the amount already authorised by the <i>Appropriation (Parliament) Act 2001</i> , section 3, to be paid for the financial year starting 1 July 2002.	17 18 19
