Health Services Amendment Act 1995

Act No. 29 of 1995

An Act to amend the *Health Services Act 1991*

[Assented to 14 June 1995]

The Parliament of Queensland enacts—**Short title**

1. This Act may be cited as the *Health Services Amendment Act 1995*.

Commencement

2. This Act commences on a day to be fixed by proclamation.
