**An Act to amend the *Egg Industry (Restructuring) Act 1993*, and for  
other purposes**

*[Assented to 15 August 1996]*

**The Parliament of Queensland enacts—****Short title**

1. This Act may be cited as the *Egg Industry (Restructuring) Amendment Act 1996*.
