## Part 1 Preliminary

### 1 Short title

This regulation may be cited as the *Government Owned Corporations (QPTC Wind-Up) Regulation 2008*.

### 2 Commencement

This regulation commences on 18 April 2008.

## Part 2 Dissolution of QPTC

### 3 Dissolution

- (1) QPTC is dissolved and its directors go out of office.
- (2) In this section—

*dissolved* includes abolished.

*QPTC* means Queensland Power Trading Corporation.
