1 Short title

This regulation may be cited as the *Place Names Regulation 2005*.

2 Excluded places

The following places are prescribed for section 4(2)(g) of the Act¹—

- (a) a marine park under the *Marine Parks Act 2004*;
- (b) a protected area under the *Nature Conservation Act 1992*.

3 Repeal

The *Place Names Regulation 1995* is repealed.
