## 1 Short title

This notice may be cited as the *Plant Protection (Cocoa Pod Borer—Pest Declaration) Notice (No. 2) 2011*.

*Note—*

Under section 4(3) of the Act, this notice remains in force until whichever of the following first happens—

- (a) the commencement of a regulation under section 4(1) of the Act in relation to the same matter;
- (b) the end of 3 months.

## 2 Pest declaration—Act, s 4(2)

*Conopomorpha cramerella* (Snellen), commonly known as cocoa pod borer, is declared to be a pest for the Act.
