# Superannuation (Public Employees Portability) Regulation 2008

## 1 Short title

This regulation may be cited as the *Superannuation (Public Employees Portability) Regulation 2008*.

## 2 Commencement

This regulation commences on 2 September 2008.

## 3 Approved superannuation schemes—Act, s 4(1)

For section 4(1) of the Act, definition *approved superannuation scheme*, paragraph (b), each superannuation scheme stated in the schedule is declared to be an approved superannuation scheme.

## 4 Prescribed matters for definition *public employment*—Act, s 4(1)

- (1) For section 4(1) of the Act, definition *public employment*, paragraph (a), the following States and Territories are prescribed—
  - (a) Queensland;
  - (b) the Northern Territory.
- (2) For section 4(1) of the Act, definition *public employment*, paragraph (b), the following authorities are prescribed—
  - (a) RESI Corporation established under the *Electricity Corporations Act 1994* (SA);
  - (b) a local government;

- (c) a State electricity entity within the meaning of the *Electricity Act 1994*;
- (d) a university established under a law of a State or Territory.
