# Transport Operations (TransLink Transit Authority) Regulation 2008

[as amended by all amendments that commenced on or before 28 November 2008]

## Part 1 Preliminary

### 1 Short title

This regulation may be cited as the *Transport Operations (TransLink Transit Authority) Regulation 2008*.

### 2 Commencement

- (1) Section 16 commences on 1 July 2008, immediately after the *Transport Legislation (Fees) Amendment Regulation (No. 1) 2008* commences.
- (2) The other provisions of this regulation commence on 1 July 2008.

## Part 2 Prescribed matter for Act

### 3 Additional service contract area for the TransLink area—Act, s 7

For section 7(1)(b) of the Act, the service contract area called the Dakabin/Mango Hill (North Lakes) service contract area is prescribed.
