ACQUISITION OF LAND REGULATION 1993

[as amended by all amendments that commenced on or before 5 July 2000]

Short title

1. This regulation may be cited as the *Acquisition of Land Regulation 1993*.

Fees—Act, ss 9 and 10

- 3.** The fee payable for an application under section 9 or 10 of the Act is—
- (a) if the application relates to 1 parcel of land—\$108.00; or
 - (b) if the application relates to more than 1 parcel of land—\$108.00 plus \$32.00 for each additional parcel of land.
