1 Short title

This regulation may be cited as the *Acquisition of Land Regulation 1993*.

2 Fees—Act, ss 9 and 10

The fee payable for an application under section 9 or 10 of the Act is—

- (a) if the application relates to 1 parcel of land—\$117.35; or
- (b) if the application relates to more than 1 parcel of land—\$117.35 plus \$34.90 for each additional parcel of land.
