# DAIRY INDUSTRY (MARKET MILK PRICES) ORDER 1999

## 1 Short title

This order may be cited as the *Dairy Industry (Market Milk Prices) Order 1999*.

## 2 Commencement

This order commences on 1 November 1999.

## 3 Definitions

In this order—

“**flavoured milk**” means milk, other than UHT milk, with the addition of flavouring.

“**flavoured UHT milk**” means UHT milk with the addition of flavouring.

“**UHT milk**” means milk treated by—

- (a) heating it to a temperature of at least 132°C for at least 1 second; and
- (b) packaging it in hermetically sealed packages as required by the Food Standards Code under the *Australia New Zealand Food Authority Act 1991* (Cwlth).

## 4 Minimum price for purchase of milk by processor—Act, s 23(1)

The minimum price to be paid by a processor for milk purchased in the following periods is the price, expressed in cents, fixed under the schedule stated for the period—

- (a) 1 November 1999 to 31 December 1999—schedule 1;
- (b) on or after 1 January 2000—schedule 2.

The *Dairy Industry (Market Milk Prices) Order (No. 2) 1998* is repealed.
