HEALTH PRACTITIONERS (SPECIAL EVENTS EXEMPTION) REGULATION 1998

1 Short title

This regulation may be cited as the *Health Practitioners (Special Events Exemption) Regulation 1998*.

2 Declaration of 2001 Goodwill Games Brisbane as special event

(1) The event known as ‘2001 Goodwill Games Brisbane’ is declared to be a special event for the Act.

(2) The exemption under the Act for the event has effect for the period starting on 29 August 2001 and ending on 10 September 2001.

3 Declaration of 14th WAVA World Veterans’ Athletics Championships as special event

(1) The event known as ‘14th WAVA World Veterans’ Athletics Championships’ is declared to be a special event for the Act.

(2) The exemption under the Act for the event has effect for the period starting on 1 July 2001 and ending on 16 July 2001.
