1 Short title

This regulation may be cited as the *Health Practitioners (Special Events Exemption) Regulation 1998*.

2 Declaration of Lexmark Indy 300 as special event

- (1) The event known as 'Lexmark Indy 300' is declared to be a special event for the Act.
- (2) The exemption under the Act for the event has effect for the period starting on 21 October 2004 and ending on 24 October 2004.
