# Health Practitioners (Special Events Exemption) Regulation 1998

[as amended by all amendments that commenced on or before 3 October 2008]

## 1 Short title

This regulation may be cited as the *Health Practitioners (Special Events Exemption) Regulation 1998*.

## 2 Declaration of Rugby League World Cup 2008 as special event

- (1) The event known as ‘Rugby League World Cup 2008’ is declared to be a special event for the Act.
- (2) The exemption under the Act for the event has effect for the period starting at midday on Monday 13 October 2008 and ending at midday on Monday 24 November 2008.

## 3 Declaration of Nikon Indy 300 as special event

- (1) The event known as ‘Nikon Indy 300’ is declared to be a special event for the Act.
- (2) The exemption under the Act for the event has effect for the period starting at midday on Wednesday 22 October 2008 and ending at midday on Monday 27 October 2008.
