VETERINARY SURGEONS REGULATION 1991

[as amended by all amendments that commenced on or before 2 November 2001]

1 Short title

This regulation may be cited as the *Veterinary Surgeons Regulation 1991*.

5 Fees

(1) The fees payable under the Act are in schedule 1.

(2) A veterinary surgeon who is an officer of the public service within the meaning of the *Public Service Management and Employment Act 1988*¹ is exempt from payment of registration fees and the annual roll fee.

5A Primary and secondary registration

(1) A person entitled to be registered as a veterinary surgeon under section 18 of the Act may apply for—

- (a) primary registration as a veterinary surgeon—if the majority of the person's practice is carried on in Queensland; or
- (b) secondary registration as a veterinary surgeon—if the majority of the person's practice is carried on in another State or a Territory.

(2) A veterinary surgeon entitled to be registered as a veterinary specialist under section 19C of the Act may apply for—

- (a) primary registration as a veterinary specialist—if the majority of the veterinary surgeon's practice is carried on in Queensland; or
- (b) secondary registration as a veterinary specialist—if the majority of the veterinary surgeon's practice is carried on in another State or a Territory.

6 Elections

(1) The registrar must give each veterinary surgeon at least 3 months notice of the day appointed by the board for the holding of triennial elections of the elective members of the board.

(2) The registrar must—

- (a) fix a date by which nominations for the election of veterinary surgeons to the board must be received; and
- (b) cause notice to be given—
 - (i) inviting veterinary surgeons to nominate candidates for election to the board; and
 - (ii) of the time and date by which nominations must be received by the returning officer.

(3) A notice under subsection (2)(b) must be published not less than 28 days before the date by which nominations must be received in 2 newspapers circulating generally throughout the State.

7 Nominations

(1) A nomination must—

- (a) nominate 1 person only; and
- (b) state the nominee's full name; and
- (c) be signed by—
 - (i) the nominee; and
 - (ii) at least 3 other veterinary surgeons; and
- (d) be received by the returning officer by noon on the day on which nominations close.

(2) A nomination may be accompanied by a candidate's statement of up to 200 words.

8 Conduct of elections

(1) The returning officer must, as soon as is practicable after nominations close, conduct a ballot of veterinary surgeons by sending to each veterinary surgeon a ballot paper, an envelope for the ballot paper and an envelope addressed to the returning officer.

(2) A ballot paper must—

- (a) contain the full names of all candidates, arranged in alphabetical order; and
- (b) specify the time and date by which completed ballot papers must be received by the returning officer; and
- (c) be initialled by the returning officer; and
- (d) be accompanied by statements (if any) furnished by the candidates.

(3) A veterinary surgeon may vote on a ballot by—

- (a) marking the ballot paper with a cross opposite the names of not more than 3 candidates; and
- (b) placing the marked ballot paper in the envelope for the ballot paper and sealing that envelope; and
- (c) placing the sealed envelope in the envelope addressed to the returning officer, signing that envelope and forwarding it to the returning officer so as to be received by the time specified on the ballot paper.

9 Count

(1) At the close of the ballot, the returning officer must—

- (a) open each envelope received by the returning officer; and
- (b) accept as formal ballot papers which are marked as required by section 8(3)(a); and
- (c) reject as informal ballot papers which are not marked as required by section 8(3)(a); and
- (d) count and record the number of formal votes for each candidate.

(2) A ballot paper is not informal merely because of an informality in the way it has been dealt with if, in the opinion of the returning officer, the intention of the voter is clear.

10 Scrutiny

Each candidate may appoint 1 scrutineer to be present when the returning officer conducts the count and must notify the returning officer of

that appointment, in writing, not less than 5 days before the close of the ballot.

11 Declaration

(1) If there are more than 3 candidates, the returning officer must declare elected from those candidates the 3 candidates who receive the highest number of votes.

(2) If 3 candidates can not be declared elected because 2 or more of them have received an equal number of votes and the number of those candidates, together with the number of candidates entitled to be declared elected exceeds 3, the returning officer must draw lots to determine which of those candidates whose votes are equal is to be declared elected.

(3) A draw conducted under subsection (2) must be conducted in the presence of the deputy registrar and the scrutineers (if any).

(4) All ballot papers used in an election must be retained by the returning officer for 3 months, and after that time must be destroyed, at a convenient time, in the presence of a member or officer of the board.

11A Veterinary qualifications—Act, s 18

(1) The qualifications recognised under section 18(1)(a)(i) of the Act are in schedule 2, part 1.

(2) The qualifications recognised under section 18(1)(a)(ii) of the Act are in schedule 2, part 2.

(3) The qualifications recognised under section 18(1)(b) of the Act are in schedule 2, part 3.

11B Specialist veterinary qualifications—Act, s 19C

The qualifications recognised under the Act, section 19C are in schedule 3.

11C Veterinary specialties—Act, s 19D

The following branches of veterinary surgery are veterinary specialties under the Act, section 19D—

- (a) anaesthesiology;

- (b) medicine;
- (c) ophthalmology;
- (d) pathobiology;
- (e) radiology;
- (f) reproduction;
- (g) surgery.

11D Veterinary surgery—Act, s 25

Veterinary surgery under the Act, section 25, does not include the following acts done for animal husbandry—

- (a) castrating of cattle, pigs, sheep and goats;
- (b) spaying of cattle;
- (c) dehorning of cattle, sheep and goats;
- (d) tailing of lambs;
- (e) mulesing of sheep;
- (f) deworming of cattle, pigs, sheep, goats, deer and poultry;
- (g) deworming of horses, except by use of stomach tube;
- (h) inoculating of horses, cattle, pigs, sheep, goats, deer and poultry with vaccines;
- (i) sampling for residue disease, when performed under the *Stock Regulation 1988*;
- (j) artificial insemination of cattle, pigs, sheep, goats, and deer;
- (k) teaching of techniques about pregnancy diagnoses of cattle by a registered veterinary surgeon to an owner of cattle.

12 Restriction on advertising

A veterinary surgeon must not—

- (a) advertise or cause or permit to be advertised, directly or indirectly, a practice of veterinary surgery; or

- (b) display or cause or permit to be displayed, directly or indirectly, a nameplate, notice or sign in relation to a practice of veterinary surgery; or
- (c) advertise or promote or cause or permit to be advertised or promoted, directly or indirectly, the sale or supply of any veterinary product; or
- (d) be associated, directly or indirectly, in or with any business advertising or promoting, or causing or permitting to be advertised or promoted the sale or supply of any veterinary product;

otherwise than as permitted by these sections.

Maximum penalty—10 penalty units.

13 Advertising

(1) A veterinary surgeon must not publish or broadcast an advertisement that—

- (a) is false, misleading or deceptive; or
- (b) is likely to mislead or deceive; or
- (c) is likely to bring the practice of veterinary surgery into disrepute.

Maximum penalty—10 penalty units.

(2) A veterinary surgeon must not publish or broadcast an advertisement that includes—

- (a) a claim about the superiority of the veterinary surgeon over another veterinary surgeon; or
- (b) a testimonial about the veterinary surgeon; or
- (c) a claim the veterinary surgeon uses superior apparatus, methods, materials or products in the practice of veterinary surgery; or
- (d) a false claim that the veterinary surgeon is a specialist in a branch of veterinary surgery; or
- (e) a statement or reference to the fees charged for veterinary services.

Maximum penalty—10 penalty units.

14 Telephone directories, etc.

(1) A veterinary surgeon must not—

(a) make more than—

- (i) 1 entry in the alphabetical listing of telephone subscribers in a telephone directory; or
- (ii) 1 entry in the alphabetical listing of veterinary surgeons in a classified telephone directory; or
- (iii) 1 entry in the locality guide to veterinary surgeons in a classified telephone directory;

for each telephone district in which the veterinary surgeon practises veterinary surgery; or

(b) make more than 1 entry in a business directory for the area in which the veterinary surgeon practises veterinary surgery;

for each place at which the veterinary surgeon practises veterinary surgery, under the veterinary surgeon's own name and the name of the association, firm or approved corporation for whom the veterinary surgeon practises veterinary surgery.

(2) An entry made in accordance with subsection (1) may, if the veterinary surgeon is a veterinary specialist, state that fact and the name of the veterinary speciality.

Maximum penalty—10 penalty units.

15 Advertising by associations, firms, corporations

An advertisement published by an association, firm or an approved corporation must include—

- (a) in the case of an association or firm, the name of each member of the association or firm who is a veterinary surgeon; or
- (b) in the case of an approved corporation, the name of each director of the corporation who is a veterinary surgeon.

Maximum penalty—10 penalty units.

16 Signs

(1) A veterinary surgeon must display at each place at which the veterinary surgeon practises veterinary surgery a sign bearing—

- (a) the veterinary surgeon's name; and
- (b) the veterinary surgeon's qualifications as recorded in—
 - (i) the Register of Veterinary Surgeons; or
 - (ii) the Register of Veterinary Specialists;as the case may be;

and stating that the person is a veterinary surgeon or, as the case may be, a veterinary specialist.

Maximum penalty—10 penalty units.

(2) A veterinary surgeon who—

- (a) is employed in a temporary capacity; or
- (b) is engaged to act in locum tenens;

for a period of not more than 30 days is not required to comply with subsection (1).

(3) A sign displayed at veterinary premises may be illuminated by a light of constant intensity and must not contain any moving parts.

Maximum penalty—10 penalty units.

(4) A veterinary surgeon must not display a sign relating to the veterinary surgeon's practice at a place other than the veterinary surgeon's veterinary premises without the approval of the board.

Maximum penalty—10 penalty units.

(5) A veterinary surgeon whose veterinary premises are in a shopping complex or other place where a directory of tenants is provided may display on that directory a sign indicating that the veterinary surgeon carries on practice in that place.

17 Records

(1) A veterinary surgeon must keep a record of veterinary examinations and procedures performed by the veterinary surgeon.

Maximum penalty—10 penalty units.

(2) The record must include—

- (a) identification of each animal treated; and
- (b) a clinical assessment of each animal's condition; and
- (c) details of tests performed; and
- (d) a provisional or definitive diagnosis; and
- (e) details of treatment administered; and
- (f) a chronological account of the management of each case.

Maximum penalty—10 penalty units.

(3) The record must be kept for at least 3 years from the date of last examination or procedure.

Maximum penalty—10 penalty units.

18 Seal

(1) The seal of the board must bear the words “The Veterinary Surgeons Board of Queensland” and the coat of arms of the State.

(2) The seal must be affixed by the registrar only to such documents as may be authorised—

- (a) by the president, in writing; or
- (b) by resolution of the board.

19 Examinations

(1) For the purposes of section 18(2)(a) of the Act, the prescribed period is 3 months.

(2) For the purposes of section 18(2)(b) of the Act, the prescribed examinations are—

- (a) an occupational English test with particular reference to veterinary surgery; and
- (b) an examination in veterinary surgery in relation to—
 - (i) companion animals; and
 - (ii) agricultural animals; and
 - (iii) public health and pathology; and

(c) a clinical examination;
conducted by the Australasian Veterinary Boards Council Incorporated.
