## **Water (Pricing Direction Notices) Repeal Regulation 2006**

[as amended by all amendments that commenced on or before 1 July 2006]

### **1 Short title**

This regulation may be cited as the *Water (Pricing Direction Notices) Repeal Regulation 2006*.

### **2 Commencement**

This regulation is taken to have commenced on 1 July 2006.

### **3 Repeal of particular instruments—Act, s 1137(2)**

(1) Each relevant notice is repealed.

(2) In this section—

*relevant notice* means—

- (a) Rural Water Pricing Direction Notice (No. 01) 2000, gazetted on 6 October 2000 at pages 429 to 432; or
- (b) Rural Water Pricing Direction Notice (No. 01) 2002, gazetted on 28 June 2002 at page 803; or
- (c) Rural Water Pricing Direction Notice (No. 02) 2002, gazetted on 27 September 2002 at page 268; or
- (d) Amendment of Rural Water Pricing Direction Notices (No. 01) 2005, gazetted on 1 July 2005 at page 678.

### **4 Expiry**

This regulation expires on 31 December 2006.
