**AMENDMENTS OF ARTICLES OF THE GOVERNMENT
OFFICERS' SUPERANNUATION SCHEME**

Short title

1. This regulation may be cited as the *Superannuation (Government and Other Employees) Amendment of Articles Regulation (No. 1) 1996*.

Commencement

2. This regulation commences on 1 February 1996.

Articles amended

3. This regulation approves the amendments of the Articles of the Government Officers' Superannuation Scheme set out in the schedule.¹

1. Section 2, definitions “employee”, “employee personal contributions”, “member” and “on a regular basis”—*omit.***2. Section 2—***insert—*‘**“member”** means a person who—

- (a) is approved to be a member of the scheme under the *Superannuation (Government and Other Employees) Notice 1996*; and
- (b) has not received the person’s full entitlement, or had the member’s accumulated contributions of the person transferred, under these articles.’.

3. Section 3 (Definition of “employee”)—*omit.***4. Article 4, heading—***omit, insert—**‘Article 4—Eligibility’.*

‘**9.(1)** This section applies while a member is receiving a payment from the Workers’ Compensation Board under the *Workers’ Compensation Act 1990* instead of salary paid by an employer.

‘**(2)** The employer must pay to the board, on the member’s behalf, the amount payable under section 8 as if the member had been engaged in the member’s normal work.’.

15. Article 6, heading—

‘Article 6—Personal contributions’.

16. Section 12, heading, ‘employee’—
