### **Amendment of s 4 (Compulsory membership)**

4. Section 4(4)—

*omit, insert—*

‘(4) This section does not apply to—

- (a) a QR employee who was not a member of the scheme on 31 January 1995; and
- (b) a person to whom section 6B applies.’.

### **Amendment of s 5 (Discretionary membership—general)**

5. Section 5(4), ‘6 and 6A’—

*omit, insert—*

‘6 to 6B’.

### **Insertion of new s 6B**

6. After section 6A—

*insert—*

**‘Discretionary membership—employees of WorkCover Queensland**

**‘6B.(1)** This section applies to a person who—

- (a) was not a member of the scheme on 31 January 1997; and
- (b) starts employment with WorkCover Queensland on or after 1 February 1997; and
- (c) is approved by the board of WorkCover Queensland to be a member of the scheme.

**‘(2)** The person is eligible to become a member of the scheme.

**‘(3)** The person’s membership of the scheme is discretionary.’.
