### **‘4 Noise Advisory Standard 1999 amended**

‘(1) The Noise Advisory Standard 1999<sup>1</sup> has been amended, including by changing the measurement of peak noise from an unweighted (linear) peak sound pressure level,  $L_{\text{peak}}$ , to a C-weighted peak sound pressure level,  $L_{\text{C,peak}}$ .

‘(2) The amendment takes effect on 1 February 2003.

‘(3) This section expires on 2 February 2003.

### **‘5 Personal Protective Equipment in Building and Construction Work Advisory Standard 1999 amended**

‘(1) The Personal Protective Equipment in Building and Construction Work Advisory Standard 1999<sup>2</sup> has been amended by replacing references to AS 1270:1988 - Acoustics - Hearing protectors with references to AS 1270:1999 - Acoustics - Hearing protectors.
