1 Short title

This regulation may be cited as the *Education (General Provisions) Amendment Regulation (No. 1) 2003*.

2 Regulation amended

This regulation amends the *Education (General Provisions) Regulation 2000*.

3 Amendment of s 60 (Allowances to certain student hostels)

1. For each student 4 years or more in preschool	466.40
2. For each student in a preparatory trial year of instruction at a school mentioned in schedule 2A, part 2	932.80
3. For each student in years 1 to 7	932.80
4. For each student in years 8 to 12	1 426.70

‘PART 3—ALLOWANCE FOR STUDENT HOSTELS

‘Division 1—If GST is not payable

For a hostel boarding—

- (a) up to 8 students—\$8 736.00 each year; or
- (b) 9 to 20 students—\$8 736.00 plus \$1 092.00 for each student more than 8 students each year; or
- (c) more than 20 students—\$21 840.00 plus \$728.00 for each student more than 20 students each year.

‘Division 2—If GST is payable

For a hostel boarding—

- (a) up to 8 students—\$9 609.60 each year; or
- (b) 9 to 20 students—\$9 609.60 plus \$1 201.20 for each student more than 8 students each year; or
- (c) more than 20 students—\$24 024.00 plus \$800.80 for each student more than 20 students each year.’.
