1 Short title

This regulation may be cited as the *Hospitals Foundations Amendment Regulation (No. 1) 2007*.

‘For section 18(3)(a)(ii) of the Act, an associated health community council mentioned in schedule 2, column 2, is the council prescribed for the body corporate mentioned opposite the council in schedule 2, column 1.’.
