# Hospitals Foundations Regulation 2005

## 1 Short title

This regulation may be cited as the *Hospitals Foundations Regulation 2005*.

## 2 Body corporate established

Each of the bodies corporate mentioned in the schedule, part 1, is established.

## 3 Bodies corporate continued in existence

- (1) Subject to subsection (2), each of the bodies corporate established under the repealed regulation and mentioned in the schedule, part 2, is continued in existence under the name stated in part 2 of the schedule.
- (2) The body corporate named Sunshine Coast Health Services Foundation established under the repealed regulation is continued in existence under the name Sunshine Coast Health Foundation.
- (3) In this section—  
*repealed regulation* means the repealed *Hospitals Foundations Regulation 1994*.

## 4 Repeal

The Hospitals Foundations Regulation 1994 SL No. 347 is repealed.
