1 Short title

This regulation may be cited as the *Hospitals Foundations Regulation 2005*.

2 Establishment of bodies corporate—Act, s 7

- (1) The body corporate named Princess Alexandra Hospital Foundation is continued in existence under the name PA Foundation.
- (2) This section expires the day it commences.
