# Hospitals Foundations Regulation 2005

[as amended by all amendments that commenced on or before 16 March 2007]

## 1 Short title

This regulation may be cited as the *Hospitals Foundations Regulation 2005*.

## 2 Establishment of bodies corporate—Act, s 7

Each of the bodies corporate mentioned in schedule 1 is established.

## 3 Prescribed associated health community councils for bodies corporate, Act—s 18(3)(a)(ii)

For section 18(3)(a)(ii) of the Act, an associated health community council mentioned in schedule 2, column 2, is the council prescribed for the body corporate mentioned opposite the council in schedule 2, column 1.

## 4 Repeal

The Hospitals Foundations Regulation 1994 SL No. 347 is repealed.
