1 Short title

This regulation may be cited as the *Hospitals Foundations Regulation 2005*.

2 Establishment of bodies corporate—Act, s 7

Each of the bodies corporate mentioned in schedule 1 is established.

3 Prescribed associated health community councils for bodies corporate, Act—s 18(3)(a)(ii)

For section 18(3)(a)(ii) of the Act, an associated health community council mentioned in schedule 2, column 2, is the council prescribed for the body corporate mentioned opposite the council in schedule 2, column 1.

4 Body corporate continued in existence

- (1) The body corporate named Royal Brisbane and Women's Hospital Research Foundation is continued in existence under the name Royal Brisbane and Women's Hospital Foundation.
- (2) This section expires the day it commences.
