## **Partnership Regulation 2004**

### **1 Short title**

This regulation may be cited as the *Partnership Regulation 2004*.

### **2 Commencement**

This regulation commences on 22 November 2004.

### **3 Fees**

- (1) The fees payable under the Act in relation to a limited partnership are in the schedule, part 1.
- (2) The fees payable under the Act in relation to an incorporated limited partnership are in the schedule, part 2.

### **4 Repeal of Partnership (Limited Liability) Regulation 1993**

- (1) The Partnership (Limited Liability) Regulation 1993 SL No. 386 is repealed.
- (2) This section expires on 23 November 2004.
