Table of changed citations and remade laws

What is the table of changed citations and remade laws

Laws are frequently repealed or remade. It can be difficult for users of legislation to keep track of changes and be sure that a reference to a law is current. This table aims to help users by listing in one place citations that have changed and laws that have been remade.

This table only relates to those laws that have been repealed (each a *repealed law*) by a law (the *repealing law*) that specifically provided that a reference to the repealed law was to be taken to be a reference to the repealing law or that otherwise made relevant provision for a change.

How citations are changed

If the citation of a law is amended, or a law is repealed and remade, references to the law in other legislation may become out of date. A reference to the repealed or remade citation may, if the context permits, be taken as a reference to the later citation.

How is it done

Listed in the table, separated into three columns, are—

- column 1 (old)—the **old short title or provision** that has been changed or is otherwise out of date
- column 2 (new)—the **new short title or provision** that replaces the out-of-date reference
- column 3 (authorising provision)—the **authorising provision** (if any) that deems a reference to the old short title or provision in column 1 to be a reference to the new short title or provision in column 2.

Additional information

Information in square brackets (‘[]’) is included for information only.

Example—

In the following reference provision, the information inside the square brackets does not form part of the replacement reference and is for information purposes only—

- Property Law Act 1974 s 241(2) [Note: This reference provision needs to be examined with care to decide whether it applies.]

Information in square brackets (in blue) in column 3 indicates where the reference provision can currently be found.

Example—

In the following reference provision, the information inside the square brackets indicates the reference can be found in the 2004 Annual Volumes, p 369—

- Legal Profession Act 2004 s 634 [2004 A.V. p 369]

If the information contained in the square brackets indicates that the reference provision has not yet commenced, the provision should be checked to make sure it has not commenced since the table was issued.

Reference provisions no longer current

Some replacement citations themselves have expired or been repealed or replaced. However, this does not result in the relevant citation in the table being changed or updated as it is intended to be the original record of the change and is to remain permanently in the table in its original form.
