NATURE CONSERVATION (PROTECTED AREAS) REGULATION 1994

[as amended by all amendments that commenced on or before 8 July 1996]

PART 1—PRELIMINARY

Short title

s 1

1. This regulation may be cited as the *Nature Conservation (Protected Areas) Regulation 1994.*

Definitions

2. In this regulation—

- "forestry chief executive" means the chief executive of the department that deals with matters arising under the *Forestry Act 1959*.
- "mining chief executive" means the chief executive of the department that deals with matters arising under the *Mineral Resources Act 1989*.

PART 2—PROTECTED AREAS (STATE LAND)

Dedication and naming of national parks (scientific)

3. Each of the areas of Crown land described in schedule 1, column 2 is—

- (a) dedicated as a national park (scientific); and
- (b) assigned the name set opposite it in the schedule, column 1.

Dedication and naming of national parks

s 4

4. Each of the areas of Crown land described in schedule 2, column 2 is—

- (a) dedicated as a national park; and
- (b) assigned the name set opposite it in the schedule, column 1.

Dedication and naming of conservation parks

5.(1) Each of the areas of Crown land described in schedule 3, column 2 is—

- (a) dedicated as a conservation park; and
- (b) assigned the name set opposite it in the schedule, column 1.

(2) Each conservation park set out in schedule 3A, column 1 is placed under the management of the trustees set out opposite it in schedule 3A, column 2.

Dedication, naming and trustees of resources reserves

6. Each of the areas of Crown land described in schedule 4, column 2 is—

- (a) dedicated as a resources reserve; and
- (b) assigned the name set out opposite it in the schedule, column 1; and
- (c) in the cases specified—placed under the management of the trustees set opposite it in the schedule, column 3.

PART 3—NATURE REFUGES

Declaration and naming of nature refuges

7. Each of the areas of land described in schedule 5 is—

- (a) declared a nature refuge; and
- (b) assigned the name specified in the schedule.

Declared management intent

8.(1) The declared management intent for a nature refuge is specified in schedule 5.

(2) Subsection (1) has effect subject to the Act, section 22 (Management principles of nature refuges).

Duration

9. The duration of the declaration of a nature refuge is stated in schedule 5.

PART 4—COORDINATED CONSERVATION AREAS

Declaration and naming of coordinated conservation areas

10. Each of the areas of land described in schedule 6 is—

- (a) declared a coordinated conservation area; and
- (b) assigned the name specified in the schedule.

Interim management intent

11.(1) The interim management intent for a coordinated conservation area is stated in schedule 6.

(2) Subsection (1) has effect subject to sections 17 and 23¹ of the Act.

Duration

s 12

12. The duration of the declaration of a coordinated conservation area is stated in schedule 6.

PART 5—MISCELLANEOUS

Reference to plan

13. In the description of an area in a schedule, a reference to a plan, the number of which uses—

- (a) the prefix 'NPW' or 'PA'—is a reference to a plan held by and available for inspection in the department; and
- (b) the prefix 'FTY'—is a reference to a plan held by and available for inspection in the department that deals with matters arising under the *Forestry Act 1959*; and
- (c) any other prefix—is a reference to a plan held by and available for inspection in the department that deals with matters arising under the *Land Act 1994*.

Description

Significant cultural and natural resources and values

7. Berlin Scrub Nature Refuge is comprised mostly of sediments (sandstones of the marburg formation) supporting—

- (a) well developed tall softwood scrub and brigalow-softwood communities; and
- (b) significant wildlife, including—
 - (i) the rare plant brown sarcochilus (Sarcochilus dilatatus), the vulnerable plant Lloyd's mock olive (Notelaea lloydii) and Hibiscus sturtii; and
 - (ii) the regent bowerbird (Sericulus chrysocephalus); and
- (c) habitat for the vulnerable black-breasted button quail (*Turnix melanogaster*).

Proposed management intent and use

8. The nature refuge will be managed, under the conservation agreement between the land-holder and the Minister, specifically—

- (a) to maintain and foster wildlife populations and communities; and
- (b) for educational purposes; and
- (c) to provide for—
 - (i) the gathering of firewood for the land-holder's personal use; and
 - (ii) controlled grazing of domestic animals by the land-holder; and
 - (iii) the construction, maintenance and use of minimal disturbance walking tracks.

Duration

9. The duration of the declaration of the nature refuge is the duration of the conservation agreement mentioned in section 4.3

8. The nature refuge supports—

- (a) significant flora, including wet sclerophyll forest, rainforest and riparian closed forest in an otherwise cleared area; and
- (b) significant fauna, including the following birds—
 - (i) the black-breasted button quail (*Turnix malanogaster*);
 - (ii) the sooty owl (*Tyto tenebricosa*);
 - (iii) the masked owl (Tyto novaehollandiae).

Proposed management intent and use

9.(1) The nature refuge is comprised of 3 areas, each of which is the subject of a separate conservation agreement.

(2) The nature refuge will be managed, under the conservation agreements, to—

- (a) maintain and foster wildlife populations and communities; and
- (b) allow scientific research and monitoring; and
- (c) allow nature based recreation for freehold tenants and invited guests.

Duration

10. For each of the areas comprising the nature refuge, the duration of the declaration of the nature refuge is the duration of the conservation agreement for the area.

1. Koala Bushland Coordinated Conservation Area.

Description

- 2. The land situated in the County of Stanley, Parish of Redland—
 - (a) containing an area of about 1 170 ha, shown hachured on plan PA3; and
 - (b) extending to a height of 1 067.5 m above the surface of the land.

Significant cultural and natural resources and values

3. The coordinated conservation area contains—

- (a) open forests and woodlands, including the following tree species—
 - (i) tallowwood (*Eucalyptus microcorys*);
 - (ii) Queensland blue gum (Eucalyptus tereticornis);
 - (iii) red mahogany (Eucalyptus resinifera);
 - (iv) grey gum (Eucalyptus propinqua);
 - (v) Queensland white stringy-bark (Eucalyptus nigra); and
- (b) a significant koala habitat that supports several hundred koalas; and
- (c) streams that support native wildlife, including the following-

- (i) platypus (Ornithorhynchus anatinus);
- (ii) 3 species of crustacean;
- (iii) 5 fish species, including the ornate rainbowfish (*Rhadinocentrus ornatus*).

Interim management intent and use

4.(1) The coordinated conservation area comprises—

- (a) 3 areas, each of which is the subject of a separate conservation agreement; and
- (b) Venman Bushland National Park.
- (2) The coordinated conservation area will be managed to—
 - (a) conserve the area's koala population and habitat; and
 - (b) conserve the area's habitat for aquatic native animals; and
 - (c) allow for a range of recreational activities, including horseriding; and
 - (d) allow for educational activities; and
 - (e) allow quarrying and commercial beekeeping on parts of the area; and
 - (f) control the landing of aircraft; and
 - (g) maintain the interests of the land-holders who are parties to the agreements.

Duration

5. The duration of the declaration of the coordinated conservation area is—

(a) for an area the subject of a conservation agreement—the duration of the agreement; and

(b) for the national park—the duration of the dedication of the national park.
