### Building Regulation 1991

## **BUILDING REGULATION 1991**

[as amended by all amendments that commenced on or before 19 September 1996]

#### Short title

**1.** This regulation may be cited as the *Building Regulation 1991*.

#### Commencement

**2.** This regulation commences on 1 January 1992.

#### **Fees**

- **3.(1)** Subject to subsection (2), the fee payable on lodging—
  - (a) an objection to a decision of a local authority—is \$90; or
  - (b) an application for variation of the *Standard Building By-laws* 1991—is \$225; or
  - (c) an appeal against a decision or determination of the Building Tribunal—is \$260.
- (2) If an objection mentioned in subsection (1)(a) or an appeal mentioned in subsection (1)(c)—
  - (a) is made before 1 April 1992; and
- (b) relates to the fencing of an existing swimming pool; no fee is payable.

#### **Forms**

**4.** The forms to be used for the purposes of an objection, application or appeal of the kind mentioned in section 3(1) are the forms approved by the chief executive.

### **Specified land**

**5.** The land described in the Schedule is specified for the purpose of section 30G(3) of the Act.

#### Declared land—Act, s 4(5)(a)(i)

**6.** Land described in schedule 2 for an electricity power station named in schedule 2 is land for which the Queensland Generation Corporation is taken to represent the State for the erection of the power station or carrying out ancillary works on the land.<sup>1</sup>

In the description of land in schedule 2, a reference to a plan is a reference to a plan held and available for inspection in the department that deals with matters arising under the *Land Act 1994* and the *Land Title Act 1994*.
