STATUTORY BODIES FINANCIAL ARRANGEMENTS (LOCAL GOVERNMENTS) ORDER 1992

[as amended by all amendments that commenced on or before 15 October 1996]

Short title

1. This order in council may be cited as the *Statutory Bodies Financial Arrangements (Local Governments) Order 1992.*

Application of Part 4 of Act

2. Part 4 of the Act (other than the provisions of those sections mentioned in section 47(2)) is declared to apply, without limit of time, to local governments, in respect of unsecured financial accommodation provided for a period of not more than 90 days by the BT Statutory and Local Authority Investment Trust.

Application of s.48(1)(d) of the Act

3. Section 48(1)(d) of the Act applies, without limit of time, to local governments in respect of investments in units in unit trusts.

Approval of investments

- **4.** For the purposes of section 48(1)(d) of the Act, investments in units in the following unit trusts are approved—
 - (a) BT Statutory and Local Authority Investment Trust;
 - (b) NMFM Cash Enhanced Fund (QLD).
