# NATURE CONSERVATION (PROTECTED AREAS) REGULATION 1994

[as amended by all amendments that commenced on or before 7 November 1996]

#### PART 1—PRELIMINARY

#### Short title

**1.** This regulation may be cited as the *Nature Conservation (Protected Areas) Regulation 1994.* 

#### **Definitions**

- 2. In this regulation—
- "forestry chief executive" means the chief executive of the department that deals with matters arising under the *Forestry Act 1959*.
- "mining chief executive" means the chief executive of the department that deals with matters arising under the *Mineral Resources Act 1989*.

#### PART 2—PROTECTED AREAS (STATE LAND)

#### **Dedication and naming of national parks (scientific)**

- **3.** Each of the areas of Crown land described in schedule 1, column 2 is—
  - (a) dedicated as a national park (scientific); and
  - (b) assigned the name set opposite it in the schedule, column 1.

#### **Dedication and naming of national parks**

- **4.** Each of the areas of Crown land described in schedule 2, column 2 is—
  - (a) dedicated as a national park; and
  - (b) assigned the name set opposite it in the schedule, column 1.

#### **Dedication and naming of conservation parks**

- **5.(1)** Each of the areas of Crown land described in schedule 3, column 2 is—
  - (a) dedicated as a conservation park; and
  - (b) assigned the name set opposite it in the schedule, column 1.
- (2) Each conservation park set out in schedule 3A, column 1 is placed under the management of the trustees set out opposite it in schedule 3A, column 2.

#### Dedication, naming and trustees of resources reserves

- **6.** Each of the areas of Crown land described in schedule 4, column 2 is—
  - (a) dedicated as a resources reserve; and
  - (b) assigned the name set out opposite it in the schedule, column 1; and
  - (c) in the cases specified—placed under the management of the trustees set opposite it in the schedule, column 3.

#### PART 3—NATURE REFUGES

#### Declaration and naming of nature refuges

7. Each of the areas of land described in schedule 5 is—

- (a) declared a nature refuge; and
- (b) assigned the name specified in the schedule.

#### **Declared management intent**

- **8.**(1) The declared management intent for a nature refuge is specified in schedule 5.
- (2) Subsection (1) has effect subject to the Act, section 22 (Management principles of nature refuges).

#### Duration

**9.** The duration of the declaration of a nature refuge is stated in schedule 5.

#### PART 4—COORDINATED CONSERVATION AREAS

#### Declaration and naming of coordinated conservation areas

- 10. Each of the areas of land described in schedule 6 is—
  - (a) declared a coordinated conservation area; and
  - (b) assigned the name specified in the schedule.

#### **Interim management intent**

- **11.(1)** The interim management intent for a coordinated conservation area is stated in schedule 6.
  - (2) Subsection (1) has effect subject to sections 17 and 231 of the Act.

Sections 17 (Management principles of national parks) and 23 (Management principles of coordinated conservation areas)

#### Duration

**12.** The duration of the declaration of a coordinated conservation area is stated in schedule 6.

#### PART 5—MISCELLANEOUS

#### Reference to plan

- **13.** In the description of an area in a schedule, a reference to a plan, the number of which uses—
  - (a) the prefix 'NPW' or 'PA'—is a reference to a plan held by and available for inspection in the department; and
  - (b) the prefix 'FTY'—is a reference to a plan held by and available for inspection in the department that deals with matters arising under the *Forestry Act 1959*; and
  - (c) any other prefix—is a reference to a plan held by and available for inspection in the department that deals with matters arising under the *Land Act 1994*.
