TRANSPORT INFRASTRUCTURE REGULATION 1995

[as amended by all amendments that commenced on or before 3 June 1998]

Short title

1. This regulation may be cited as the *Transport Infrastructure Regulation 1995*.

Miscellaneous transport infrastructure

2. For the purposes of schedule 31 of the Act—

"miscellaneous transport infrastructure" includes—

- (a) a pipeline (whether underground or aboveground) for transporting chemical, gas or petroleum products, or mineral slurry; and
- (b) a conveyor belt; and
- (c) works constructing, facilitating the operation of, or maintaining the pipeline or conveyor belt.

Continuation of operation of Act, s 235

3. The operation of section 235 of the Act (other than subsection (1)) is extended past the time it would otherwise expire until 30 June 1999.
