### **BUSINESS NAMES REGULATION 1998**

[as amended by all amendments that commenced on or before 9 October 1998]

#### Short title

**1.** This regulation may be cited as the *Business Names Regulation 1998*.

# Obtaining Minister's consent to registration of particular business names

- **2.(1)** An application, under section 9(1) of the Act,<sup>1</sup> for the Minister's consent to registration of a particular business name must be given to the registrar together with the application fee.
- (2) The application must be written, signed by or for the applicant, and state the reasons why the applicant considers the consent should be given.

#### Fees

**3.** The fees payable under the Act are in the schedule.

### Waiving late lodgment fee

- **4.(1)** This section applies if a person lodges a statement with the registrar later than is required under section 11(1) or 12 of the Act.<sup>2</sup>
- (2) If the person satisfies the registrar that the person has a reasonable excuse for the late lodgement, the registrar may waive the late lodgement fee.

Section 9 (Restriction on registration of business names that are undesirable etc.)

Section 11 (Renewal of registration) or 12 (Notification of changes in particulars relating to registered business names, cessation of business etc.)

# Repeal

**5.** The *Business Names Regulation 1986* is repealed.
