1 Short title

This notice may be cited as the Workplace Health and Safety (Advisory Standards) Notice 1998.

2 Commencement

This notice commences on 1 July 1998.

3 Making advisory standards

The documents mentioned in the schedule have been made as advisory standards. $^{\scriptscriptstyle 1}$

4 Falls from Heights Advisory Standard amended

(1) The Falls from Heights Advisory Standard 2000² has been amended, including by inserting more specific information on managing working at height risks in housing construction.

(2) This section expires 7 days after its commencement.³
