BUSINESS NAMES REGULATION 1998

[as amended by all amendments that commenced on or before 1 August 2002]

1 Short title

This regulation may be cited as the Business Names Regulation 1998.

2 Obtaining Minister's consent to registration of particular business names

- (1) An application, under section 9(1) of the Act,¹ for the Minister's consent to registration of a particular business name must be given to the registrar together with the application fee.
- (2) The application must be written, signed by or for the applicant, and state the reasons why the applicant considers the consent should be given.

3 Fees

The fees payable under the Act are in the schedule.

4 Waiving late lodgment fee

- (1) This section applies if a person lodges a statement with the registrar later than is required under section 11(1) or 12 of the Act.²
- (2) If the person satisfies the registrar that the person has a reasonable excuse for the late lodgement, the registrar may waive the late lodgement fee.

5 Repeal

The Business Names Regulation 1986 is repealed.
