# **ARCHITECTS REGULATION 2003**

### 1 Short title

This regulation may be cited as the Architects Regulation 2003.

### 2 Prescribed school of architecture—Act, s 82

For section  $82(2)(a)(i)^1$  of the Act, each of the following is a prescribed school of architecture—

- School of Design and Built Environment, Queensland University of Technology
- School of Geography, Planning & Architecture, The University of Queensland.

#### 3 Fees

- (1) The fees payable under the Act are stated in the schedule.
- (2) This section and the schedule expire on 30 June 2004.

#### 4 Repeal

The Architects Regulation 2002 SL No. 348 is repealed.
