# 1 Short title

This regulation may be cited as the Acquisition of Land Regulation 2003.

## 2 Fees—Act, ss 9 and 10

The fee payable for an application under section 9 or 10<sup>1</sup> of the Act is—

- (a) if the application relates to only 1 parcel of land—\$120.90; or
- (b) if the application relates to more than 1 parcel of land—\$120.90 plus \$35.95 for each additional parcel of land.

### 3 Repeal

The Acquisition of Land Regulation 1993 is repealed.
