## Acquisition of Land Regulation 2003

[as amended by all amendments that commenced on or before 1 July 2005]

#### 1 Short title

This regulation may be cited as the Acquisition of Land Regulation 2003.

#### 2 Fees—Act, ss 9 and 10

The fee payable for an application under section 9 or  $10^{1}$  of the Act is—

- (a) if the application relates to only 1 parcel of land—\$124; or
- (b) if the application relates to more than 1 parcel of land—\$124 plus \$36.85 for each additional parcel of land.

#### 3 Repeal

The Acquisition of Land Regulation 1993 is repealed.
