## **Acquisition of Land Regulation 2003**

[as amended by all amendments that commenced on or before 1 July 2014]

### 1 Short title

This regulation may be cited as the Acquisition of Land Regulation 2003.

### 2 Fee—Act, s 9

The fee payable for an application under section 9 of the Act is—

- (a) if the application relates to only 1 parcel of land—\$167.90; or
- (b) if the application relates to more than 1 parcel of land—\$167.90 plus \$49.80 for each additional parcel of land.

### 3 Repeal

The Acquisition of Land Regulation 1993 is repealed.
