Bail of Persons Committed for Sentence on

**)** E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Queensland in Parliament assembled, and by the authority of the same, as follows :---

1. This Act may be cited as "The Justices Act Short title and construction Amendment Act of 1924," and shall be read as one with of Act.

\*"The Justices Acts, 1886 to 1909," herein collectively referred to as the Principal Act.

2. The following provision is added to section one Amendment hundred and thirteen of the Principal Act :-- of s. 113 of Principal

"Provided that in any case where the court of Act. petty sessions before which the defendant under this section has admitted his guilt is constituted by a police magistrate, such police magistrate, after ordering the defendant to be committed for sentence as hereinbefore provided, may in his discretion (except in the cases of offences mentioned in section one hundred and fourteen hereof as amended by section six of *†*"The Criminal Code Amendment Act of 1922"), admit the defendant to bail upon his entering into a recognizance with such surety or sureties as in the opinion of the police magistrate will be sufficient to ensure his appearance at the time and place when and where he is to be sentenced for the offence; but if the defendant fails to give bail the police magistrate shall, by his warrant, commit him to gaol, to be there safely kept until the sittings of the Court to which he is committed for sentence, or until he is delivered by due course of law:

Provided further that in any case in which the court of petty sessions before which the defendant under this section has admitted his guilt is constituted otherwise than by a police magistrate, such court shall have no jurisdiction to grant bail to the defendant as last hereinbefore provided, but the defendant may make application for bail in all such cases (other than cases of the offences mentioned in section one hundred and fourteen hereof as amended by section six of *†*" The Criminal Code Amendment Act of 1922") to a police magistrate, and such police magistrate may in his discretion admit the defendant to bail upon his entering into a recognizance with such surety or sureties as in the opinion of the police magistrate will be sufficient to ensure his appearance at the time and place when and where he is to be sentenced for the offence, but if the defendant fails to give bail the warrant of commitment of the defendant to gaol by the court of petty sessions shall continue in full force and effect."
