BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Queensland in Parliament assembled, and by the authority of the same, as follows:—

#### PART II—AMENDMENT OF NURSING STUDIES ACT 1976–1978

- 3. Citation. (1) In this Part the Nursing Studies Act 1976-1978 is referred to as the Principal Act.
- (2) The Principal Act as amended by this Part may be cited as the *Nursing Studies Act* 1976-1984.
- 4. Amendment of s. 7. Members of Board. Section 7 of the Principal Act is amended by—
- (a) omitting from subsection (3) the words "Adviser in Nursing, Department of Health" and substituting the words "Chief Nursing Officer in Queensland appointed pursuant to the provisions of the *Hospitals Act* 1936–1984":
  - (b) omitting subsection (8).

5. Amendment of s. 24. Accredited school of nursing to issue certificate etc. Section 24 of the Principal Act is amended by omitting the words "in the prescribed form" and substituting the words "to that effect".

  - "12. Entitlements of members of Board and committees. (1) Members of the Board and members of a committee formed pursuant to section 11 shall be entitled to such fees and allowances as are approved by the Governor in Council save that a member of the Board or that committee who is an officer of the Public Service of Oueensland shall not receive fees or allowances for attendance at a meeting of the Board or that committee during his ordinary hours of duty.
  - (2) Members of the Board and members of a committee shall be entitled to be re-imbursed such out of pocket expenses necessarily incurred by them in the performance of their duties as such members as are approved by the Board.".

  - "13. Entitlements of members of Board or committees. (1) Members of the Board and members of a committee formed pursuant to section 12 shall be entitled to such fees and allowances as are approved by the Governor in Council save that a member of the Board or that committee who is an officer of the Public Service of Queensland shall not receive fees or allowances for attendance at a meeting of the Board or that committee during his ordinary hours of duty.

- 11. Repeal of and new s. 13. The Principal Act is amended by repealing section 13 and substituting the following section:—
  - "13. Entitlements of members of Board or committees. (1) Members of the Board and members of a committee formed pursuant to section 12 shall be entitled to such fees and allowances as are approved by the Governor in Council save that a member of the Board or that committee who is an officer of the Public
  - Service of Oueensland shall not receive fees or allowances for attendance at a meeting of the Board or that committee during his ordinary hours of duty.
  - (2) Members of the Board and members of a committee shall be entitled to be re-imbursed such out of pocket expenses necessarily incurred by them in the performance of their duties as such members as are approved by the Board.".

#### PART VII—AMENDMENT OF MEDICAL ACT 1939-1984

- 14. Citation. (1) In this Part the Medical Act 1939–1984, being the Medical Act 1939-1981 as amended by the Medical Act Amendment Act 1984, is referred to as the Principal Act.
- (2) The Principal Act as amended by this Part may be cited as the Medical Act 1939-1984.

- 15. Repeal of and new s. 9B. The Principal Act is amended by repealing section 9B and substituting the following section:—
  - "9B. Entitlements of members of Board or committees.

    (1) Members of the Board and members of a committee formed pursuant to section 9A shall be entitled to such fees and allowances as are approved by the Governor in Council save that a member of the Board or that committee who is an officer of the Public Service of Queensland shall not receive fees or allowances for attendance at a meeting of the Board or that committee during his ordinary hours of duty.
  - (2) Members of the Board and members of a committee shall be entitled to be re-imbursed such out of pocket expenses necessarily incurred by them in the performance of their duties as such members as are approved by the Board.".

    (1) Members of the Board and members of a committee formed pursuant to section 16 shall be entitled to such fees and allowances as are approved by the Governor in Council save that a member of the Board or that committee who is an officer of the Public Service of Queensland shall not receive fees or allowances for attendance at a meeting of the Board or that committee during his ordinary hours of duty.
  - (2) Members of the Board and members of a committee shall be entitled to be re-imbursed such out of pocket expenses necessarily incurred by them in the performance of their duties as such members as are approved by the Board.".

    (1) Members of the Board and members of a committee formed pursuant to section 12 shall be entitled to such fees and allowances as are approved by the Governor in Council save that a member of the Board or that committee who is an officer of the Public Service of Queensland shall not receive fees or allowances for attendance at a meeting of the Board or that committee during his ordinary hours of duty.

  - (2) Members of the Board and members of a committee shall be entitled to be re-imbursed such out of pocket expenses necessarily incurred by them in the performance of their duties as such members as are ap roved by the Board.".
