

## ELIZABETHAE SECUNDAE REGINAE

An Act to divest certain estates and interests in certain freehold and leasehold land and the improvements thereon from certain registered proprietors and lessees and, according to the location of the land, to vest estates and interests in the land in The Corporation of the Trustees of the Roman Catholic Archdiocese of Brisbane, the Roman Catholic Trust Corporation for the Diocese of Townsville or The Corporation of the Roman Catholic Diocese of Toowoomba in each case freed and discharged from any trusts upon which the land is held, to provide for the similar divesting and vesting of other land and for related purposes
[Assented to 27th September, 1985]

Preamble. Whereas certain estates and interests in freehold and leasehold land set out and described in the Schedules are held in the names of various registered proprietors and lessees on behalf of the Roman Catholic Church:

And Whereas as far as can be ascertained all those registered proprietors and lessees are deceased:

And Whereas The Corporation of the Trustees of the Roman Catholic Archdiocese of Brisbane constituted under the Religious Educational and Charitable Institutions Act 1861-1967 (repealed) is authorized to hold land for the Roman Catholic Church in the Brisbane Archdiocese:

And Whereas it is desirable to vest such of the land as is located in the Brisbane Archdiocese in The Corporation of the Trustees of the Roman Catholic Archdiocese of Brisbane freed and discharged from any trusts upon which that land is presently held:

And Whereas the Roman Catholic Trust Corporation for the Diocese of Townsville constituted under the Religious Educational and Charitable Institutions Act 1861-1967 (repealed) is authorized to hold land for the Roman Catholic Church in the Townsville Diocese:

And Whereas it is desirable to vest such of the land as is located in the Townsville Diocese in the Roman Catholic Trust Corporation for the Diocese of Townsville freed and discharged from any trusts upon which the land is presently held:

And Whereas The Corporation of the Roman Catholic Diocese of Toowoomba constituted under the Religious Educational and Charitable Institutions Act 1861-1967 (repealed) is authorized to hold land for the Roman Catholic Church in the Toowoomba Diocese:

And Whereas it is desirable to vest such of the land as is located in the Toowoomba Diocese in The Corporation of the Roman Catholic Diocese of Toowoomba freed and discharged from any trusts upon which the land is presently held:

BE IT THEREFORE ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Queensland in Parliament assembled, and by the authority of the same, as follows:-

1. Short title. This Act may be cited as the Roman Catholic Church Lands Act 1985.
2. Vesting of certain land in The Corporation of the Trustees of the Roman Catholic Archdiocese of Brisbane. The estate and interest in the land set out and described in the First Schedule and any improvements thereon is hereby divested from each person who, at the passing of this Act, is the registered proprietor or lessee and vests in The Corporation of the Trustees of the Roman Catholic Archdiocese
of Brisbane constituted under the Religious Educational and Charitable Institutions Act 1861-1967 (repealed) completely freed and discharged from the trusts (if any) under which the land is presently held.
3. Vesting of certain land in the Roman Catholic Trust Corporation for the Diocese of Townsville. The estate and interest in the land set out and described in the Second Schedule and any improvements thereon is hereby divested from each person who, at the passing of this Act. is the registered proprietor or lessee and vests in the Roman Catholic Trust Corporation for the Diocese of Townsville constituted under the Religious Educational and Charitable Institutions.Act 1861-1967 (repealed) completely freed and discharged from the trusts (if any) under which the land is presently held.
4. Vesting of certain land in the Corporation of the Roman Catholic Diocese of Toowoomba. The estate and interest in the land set out and described in the Third Schedule and any improvements thereon is hereby divested from each person who, at the passing of this Act, is the registered proprietor or lessee and vests in The Corporation of the Roman Catholic Diocese of Toowoomba constituted under the Religious Educational and Charitable Institutions Act 1861-1967 (repealed) completely freed and discharged from the trusts (if any) under which the land is presently held.
5. Duty of Registrar of Titles and others. The Registrar of Titles, a Deputy Registrar of Titles, the Registrar of Dealings, a mining warden or other person required by any Act or law to make or enter any note or memorial on any certificate or other instrument of title to land shall, upon receipt of a duly completed request in that behalf by the relevant corporation, payment of the appropriate fees (if any) and production of all relevant certificates or other instruments of title and, if any certificate of other instrument of title is missing, a duly completed statutory declaration stating the reasons for the failure to produce that certificate or other instrument. give effect in the register book to the divesting and the vesting in accordance with this Act by making every entry. cancellation and correction in any register, record or book in his custody or under his control and do and execute such other acts, matters and things as to him appear necessary and proper.

For the purposes of this section the expression "relevant Corporation" means-
(a) in relation to land described in the First Schedule. The Corporation of the Trustees of the Roman Catholic Archidiocese of Brisbane:
(b) in relation to land described in the Second Schedule, the Roman Catholic Trust Corporation for the Diocese of Townsville;
(c) in relation to land described in the Third Schedule. The Corporation of the Roman Catholic Diocese of Toowoomba.
6. Amendment of Schedules. (1) (a) The Governor in Council may from time to time by Order in Council amend the First Schedule by adding thereio a description of land held on behalf of the Roman Catholic Church and located in the Brisbane Archdiocese in addition to the land set out and described therein.

Upon amendment. the First Schedule as so amended shall be taken to be the First Schedule to this Act.
(b) The Governor in Council may from time to time by Order in Council amend the Second Schedule by adding thereto a description of land held on behalf of the Roman Catholic Church and located in the Townsville Diocese in addition to the land set out and described therein.

Upon amendment. the Second Schedule as so amended shall be taken to be the Second Schedule to this Act.
(c) The Governor in Council may from time to time by Order in Council amend the Third Schedule by adding thereto a description of land held on behalf of the Roman Catholic Church and located in the Toowoomba Diocese in addition 10 the land set out and described therein.

Upon amendment. the Third Schedule as so amended shall be taken to be the Third Schedule to this Act.
(d) Where a description of land is added by Order in Council to the First Schedule, the Second Schedule or the Third Schedule pursuant to this section. the provisions of -
(i) in a case of an addition to the First Schedule, section 2:
(ii) in a case of an addition to the Second Schedule, section 3:
(iii) in a case of an addition to the Third Schedule. section 4.
and section 5 shall apply in respect of that land as if this Act had been passed at the time the Order in Council takes effect.
(2) An order in Council made for the purposes of subsection (1) shall be laid before the Legislative Assembly within 14 sitting days after its publication in the Gazette.
(3) An Order in Council referred to in subsection (2) shall have no effect until whichever of the following events, being appropriate to the case. is the earlier to occur:-
(a) if. within 14 sitting days after the Order in Council has been laid before it (whether within the period prescribed by subsection (2) or subsequently). notice of motion to disallow the order is given in the Legislative Assembly. the question that the order be disallowed is resolved by the Assembly in
the negative or as the case may be, the motion lapses in accordance with Standing Orders of the Assembly:
(b) if within the period referred to in paragraph (a) a notice of motion referred to in that paragraph is not given. the expiration of that period.
(4) For the purposes of this section a prorogation of the Parliament or a dissolution of the Legislative Assembly shall not affect the power of the Assembly to disallow an Order in Council and in all respects relevant to an exercise of that power shall be disregarded.
