BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Queensland in Parliament assembled, and by the authority of the same, as follows:—

- 1. Short title. This Act may be cited as the Public Service (Administrative Arrangements) Act 1990 (No. 2).
- 2. Commencement. (1) Subject to subsections (2), (3), (4), (5) and (6), this Act commences on the day on which it is assented to for and on behalf of Her Majesty.
