An Act to amend the TAB Queensland Limited Privatisation Act 1999

[Assented to 6 November 2003]

#### The Parliament of Queensland enacts—

#### 1 Short title

This Act may be cited as the TAB Queensland Limited Privatisation Amendment Act 2003.

#### 2 Commencement

This Act commences on a day to be fixed by proclamation.

#### 3 Act amended

This Act amends the TAB Queensland Limited Privatisation Act 1999.

#### 4 Amendment of s 18 (Definition for pt 3)

(1) Section 18, heading, 'Definition'—

'Definitions'.

(2) Section 18, definition "cornerstone investor"— *omit.* 

#### 5 Omission of s 24 (Cornerstone investor)

#### 6 Amendment of s 26 (Prohibited shareholding interest)

(1) Section 26(1), 'the cornerstone investor'—

omit, insert—

'Tab Limited (ABN 17 081 765 308)'.

(2) Section 26(2)—
omit, insert—

- '(2) Tab Limited has a prohibited shareholding interest in TABQ if it is entitled to voting shares in TABQ that together constitute more than 10% of the total number of voting shares in TABQ unless the shares were acquired under an arrangement approved by a court under the Corporations Act, section 411(6) and notified by the Minister by gazette notice.'.
  - (3) Section 26(4)— *omit.*
  - (4) Section 26(5) and (6)—
    renumber as section 26(4) and (5).

Part 3, divisions 3 and 4—*omit*.

      - chief financial officer;
      - general counsel;
      - · chief human resources officer; and
    - (d) each annual general meeting of the company to be held in Queensland.'.

- '(c) in each year, at least 4 of the company's board meetings are held in Queensland; and
- (d) each meeting of the company's board held annually for the purpose of strategic planning is held in Queensland.'.
