Residential Services and Other Legislation Amendment Act 2004

Act No. 10 of 2004

An Act to amend the *Residential Services (Accommodation) Act 2002*, the *Residential Services (Accreditation) Act 2002* and other legislation

[Assented to 31 May 2004]

The Parliament of Queensland enacts—

PART 1—PRELIMINARY

1 Short title

This Act may be cited as the *Residential Services and Other Legislation Amendment Act 2004*.

PART 2—AMENDMENT OF RESIDENTIAL SERVICES (ACCOMMODATION) ACT 2002

This part amends the Residential Services (Accommodation) Act 2002.

(2) The dictionary in the schedule defines what is a residential service for this Act mainly by reference to the definition "residential service" under the accreditation Act.

(3) The accreditation Act establishes systems for the registration and accreditation of residential services under that Act, to ensure the services are conducted at an appropriate standard.'.

'132A Meaning of "independent student accommodation service"

(1) An "independent student accommodation service" is a service that—

- (a) is conducted mainly to provide accommodation to persons who are enrolled in courses that, under the *Social Security Act 1991* (Cwlth), section 569B, are approved courses of education or study for section 569A(b)¹ of that Act; and
- (b) is of a type mentioned in the accreditation Act, section 4(1), (2) or (3); and
- (c) is not a service mentioned in the accreditation Act, section 4(5)(e), (f) or (h).

'(2) For subsection (1)(b), in deciding whether a service is of a type mentioned in the accreditation Act, section 4(1), section 4(4) of that Act applies.'

"residential service" means-

- (a) a residential service under the accreditation Act, section 4;² or
- (b) an independent student accommodation service.

"unregistered service" means—

- (a) a residential service that is not registered under the accreditation Act; or
- (b) an independent student accommodation service.'.
