**An Act to amend the TAB Queensland Limited Privatisation Act  
1999 and for other purposes**

**[Assented to 27 October 2004]**

**The Parliament of Queensland enacts—**

## **Part 1 Preliminary**

### **1 Short title**

This Act may be cited as the *TAB Queensland Limited Privatisation Legislation Amendment Act 2004*.

### **2 Commencement**

- (1) Part 2, other than section 5(2), commences on 5 November 2004.
- (2) Section 5(2) commences on 1 January 2005.

## **Part 2 Amendment of TAB Queensland Limited Privatisation Act 1999**

### **3 Act amended in pt 2**

This part amends the *TAB Queensland Limited Privatisation Act 1999*.

### **4 Replacement of s 43 (Application of pt 5)**

Section 43—

*omit, insert—*

### **‘43 Application of pt 5**

‘This part applies only to a TABQ group company that is—

- (a) a licensed monitoring operator under the *Gaming Machine Act 1991*; or

- (b) a wagering licensee or a wagering manager under the *Wagering Act 1998*.’.

**5 Amendment of s 44 (TABQ group companies to have constitutions containing certain provisions)**

- (1) Section 44(2)(b)—

*omit, insert—*

- ‘(b) at least 3 of the directors of the company to be ordinarily resident in Queensland; and
- (c) the chief executive officer of the company to be ordinarily resident in Queensland; and
- (d) each annual general meeting of the company to be held in Queensland.’.

- (2) Section 44(3)(c)—

*omit, insert—*

- ‘(c) in each year, at least 4 of the company’s board meetings are held in Queensland; and
- (d) each meeting of the company’s board held annually for the purpose of strategic planning is held in Queensland.’.

**6 Amendment of s 50 (Pt 5 overrides Corporations Law)**
