**Short title**

1. This regulation may be cited as the *Building Fire Safety Amendment Regulation (No. 1) 1993*.

**Amended regulation**

2. The *Building Fire Safety Regulation 1991* is amended as set out in this regulation.

**Amendment of s.21 (Search as to whether notice to comply has been given)**

7. Section 21(1)(a)—

*omit* ‘the Act’, *insert* ‘the Fire Service Act’.
