### **Short title**

1. This regulation may be cited as the *Nature Conservation (Protected Areas) Amendment Regulation (No. 3) 1997*.

## **‘PART 6—REVOCATION OF PARTS OF PROTECTED AREAS**

### **‘Revocation of dedication of parts of protected areas**

‘14. The dedication of each of the protected areas named in schedule 7, column 1 is revoked, in part, to the extent of the areas of land described opposite in schedule 7, column 2.

### **‘Expiry of part and sch 7**

‘15. This part and schedule 7 expire the day after they commence.’.
